Sir/Madam,

With reference to your application dated 24.03.2007 and subsequent correspondence with the school/inspection in this regard, I am directed to convey the sanction for Composite Provisional Affiliation for Secondary School Examination of the Board for a period of three years w.e.f. 01.04.2008 to 31.03.2011.

The above sanction is subject to the fulfillment of the following conditions:

1. The school will follow the syllabus on the basis of curriculum prescribed by NCERT for the Middle Classes.
2. The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Secondary School Examination and changes made therein from time to time.
3. The school shall appoint only qualified and eligible staff.
4. The school will help the Board in the smooth conduct of the examination by providing the necessary accommodations i.e. Rooms, Halls, etc. available in the school premises and furniture at its disposal for holding its examinations free of charges if required.
5. The school will spare sufficient teachers, for invigilation purpose at the examinations of the Board, as may be required
6. The school will spare its teachers for evaluation of answer-books for the Board's examinations, if required.
7. The school will provide Laboratories, Library and other facilities as per norms of the Board.
8. The school will abide itself by the conditions of affiliation already prescribed by the State Government concerned.

9. Service agreement be executed with the staff as per norms generally accepted by the State Government concerned.
10. Service conditions pay and allowance and other benefits to the employees of the school shall be in no way less than that of corresponding employees working in Government Schools of the State in which the school is located. An undertaking to this effect be sent to C.B.S.E.
11. The school and its records shall be opened for inspection by an officer/official of the Board or an authorized representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.
12. The rate of tuition fee and other fees charged should be commensurate with the facilities provided.
13. The admission to the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.
14. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
15. The School will not sponsor candidates for Board's examination of any other School/Branch, which is not affiliated.
16. The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws/Rules of the Directorate of Education, Delhi in the joint names.
17. The school should not start Class XI/XII without written approval of the Board. The Board shall not be responsible for any consequences in case class XI/XII is started without following the Affiliation Bye Laws and obtaining the prior approval of the Board.
18. The affiliation Code Number allotted to your school is 830226. This may please be noted and quoted for any correspondence with the Board.
19. Annual fee Rs. 4500/- @ Rs.1500/- per annum for the year(s) (1.04.2008 to 31.03.2011) be also remitted at an early date.
20. The school should apply for further Extension of Provisional Affiliation before 30th June of the preceding year before the expiry of the date of Affiliation 'On Line' through CBSE Website www.cbseaff.nic.in or www.cbse.nic.in and send a copy of its confirmation page with prescribed fee of Rs. 12,500/- in the shape of Bank Draft drawn in favour of Secretary, CBSE, Delhi.
21. Renewal of Registration of Society be ensured.
22. "The school has been granted affiliation upto Secondary level w.e.f. 01.04.2008 accordingly it has become eligible to open CBSE pattern classes IX from the session 2008-09 and 1st Batch of class X of the school will be appearing at the CBSE Examination to be held in the year 2010.
23. Other conditions are as per Annexure 'A' enclosed.

Conditions for immediate compliance:

1. Salary is paying to the staff by cash whereas salary should be paid through bank transfer against single cheque issued in favour of the Bank.
 2. The school is required to arrange one activity hall for co-curricular activities and SUPW subjects.
 3. The school is required to issue the proper appointment letter to the staff.
 4. The school is required to procure more books in the library for developing interest of the students in reading and strengthening of general awareness Also library may be furnished adequately.

5. The school is required to re-constitute the SMC as per the provisions of Affiliation Bye-laws of the Board and ensure that no blood relation is there in the S.M.C.
6. The school is required to sponsor their teachers to attend workshops and orientation courses organized by reputed Teachers Training Institute.
7. The school is required to develop the playground with adequate provisions for sports and games.
